#### **RESOLUTIONS**:

- **4.01** Ms. K Hemamalini, Chairman, Board of Studies invited all the members cordially to the meeting and introduced new members to the Board.
- **4.02** The minutes of 3<sup>rd</sup> Board of Studies meeting were presented and ratified. Minutes Department Academic Committee meeting held on 5<sup>th</sup> July, 2018 were presented and approved.
- **4.03** The revised academic regulations of B.Sc. Hotel Management program was presented and approved

#### The following changes have been made in the evaluation pattern:

- The internal evaluation weight age has been increased to 60 % from previous 50 % both for theory and practical.
- The external evaluation weight age has been reduced to 40 % from previous 50 % both for theory and practical.
- The Comprehensive semester examination has been revised to 40 marks instead of 50 covering four CO's both for theory and practical.
- Attendance, the minimum eligibility of attendance has been revised to 85 % in the semester for writing the exams. Condonation has been revised from 75 % to 85 % and below 75 % can be given only on the recommendations of the VC or Dean Academics.

- **4.04 Academic** calendar of B.Sc. Hotel Management Program were presented and approved.
- **4.05** Changes in the program structure of B.Sc. Hotel Management Program by introducing industry driven courses were approved.
  - ➤ In Academics following changes have been made in the student internship program (SIP): The four months internship in the final semester has been shifted to II year second semester with 6 months internship period. After first year summer break students will undergo 45 days internship.
  - The three year Degree program will be called B.Sc. in hotel Management
  - English syllabus changes have been introduced in all the three years and been approved.
  - The following four courses have been added in the curriculum as value added courses: 1. Universal human values in I year II Semester 2. Ecology & Environment in II year II semester 3. Indian heritage and culture III year I semester 4. Campus to corporate in III Year II semester
  - It was proposed and approved by Dean-Academics to include Hindi also in the first year II semester.
  - Travel & Tourism is revised as Travel & Tourism Management and has been shifted to VI semester. Some additional topics have been included in the syllabus.
  - In the final VI Semester three electives have been added
    - 1. Advanced Food Production
    - 2. Advanced food & beverage service
    - 3. Advanced Accommodation Management
